Limited Services

Forwarding of Remains to Another Funeral Firm \$ 2,800.00

This charge includes the local transfer of the remains to the funeral firm, staff services, securing of necessary authorizations, local transportation to the point of shipment. This charge does not include shipping charges or additional items of services, merchandise, facility use and livery that the customer may wish to select. Transfer or other transportation by funeral firm livery beyond a radius of 25 miles is subject to an additional charge of \$ 2.75 per mile. Transportation by common carrier is not included in the above charge.

Receiving of Remains from Another Funeral Firm \$ 1,800.00

This charge includes the basic local transportation of the remains to the funeral firm and/or place of local disposition, staff services and securing necessary authorizations. The charge does not include additional items of service, merchandise, facility use, and livery that the customer may wish to select. Transfer or other transportation by funeral firm livery beyond a radius of 25 miles is subject to an additional charge of \$ 2.75 per mile. Transportation by common carrier is not included in the above charge.

These prices are effective as of January 1, 2018 and are subject to change without notice.

The Federal Trade Commission (FTC) and the New York State Department of Health require funeral providers to make certain disclosures on the General Price List.

These disclosures are similar, but are not exactly the same.

The General Price List contains the disclosures required by the New York State Department of Health.

The goods and services shown within are those we can provide to our customers. You may choose only items you desire. However, any funeral arrangements you select will include a charge for our services. If legal or other requirements mean you must buy any items you did not specifically ask for, we will explain the reason in writing on the statement we provide describing the funeral services and merchandise you selected.

This list may not include prices for certain items that you select, such as cemetery charges or crematory services, flowers and newspaper notices. The estimated or final prices for those items will be shown on the itemized statement describing the funeral services and merchandise you selected. We charge you for our services in buying certain items.

Alternative Services

The following charges for direct burial and direct cremation do not include items of service, merchandise, use of facilities and livery that the customer may wish to select.

Direct Cremation

Prices range from \$2,300.00 to \$ 3,000.00

Direct Cremation includes the local transfer of remains to the funeral firm, the services of the funeral director and staff, securing of necessary authorizations, basic local transportation to the crematory, an alternative container for the cremation and the return of the cremated remains to the funeral firm.

If you want to arrange a direct cremation, you may use an unfinished wooden box or an alternative container. Alternative containers can be made of heavy cardboard, pressed wood or composition materials (with or without an outside covering), or maybe pouches of canvas or other materials.

The direct cremation prices do not include the crematory charge.

Direct Burials

Prices ranges from \$ 2,300.00 to \$ 2,500.00

The first package includes the transfer of remains to the funeral firm, services of the funeral director and staff, securing of necessary authorizations, basic local transportation to the cemetery and alternative container \$ 2,500.00

The second package includes the services described above but with the burial container supplied by the purchaser \$ 2,300.00

The alternative container is a flat- top, heavy cardboard. The direct burial prices do not include the cemetery charges.

In New York State, embalming is not required by law. If you do not want embalming, you have the right to choose an arrangement which does not require you to pay for embalming such as a direct cremation or direct burial. If you select certain funeral arrangements, such as viewing or open casket funeral, embalming may be required by the funeral firm.

Preparation of remains, unless selected, is not required for direct cremation or direct burial.
